1. COURSE GOAL(s)

The goals of the course are to:

The purpose of mastering the discipline "Comparative criminal law" is to provide students with theoretical knowledge about the criminal law of foreign countries, as a branch of law, a scientific discipline. After completing the course, the student should have a clear understanding of the concept of the development of modern criminal law in foreign countries - developed and developing; main criminal law directions and schools, sources of criminal law in foreign countries, the concept of a crime in the criminal law and doctrine of developed and developing countries; study the concepts of guilt, criminal law theories of complicity, stages and criminal law assessment of preliminary criminal activity in the criminal law of foreign countries, the concept, goals and system of punishments, as well as get acquainted with groups and certain types of specific crimes based on the criteria for building a system of a special part of a foreign criminal law, to understand for themselves the basics of the qualification of crimes, taking into account their description in the dispositions of the norms.

The purpose of this course is to give students the necessary legal knowledge in the field of criminal law of foreign countries - developed and developing, which is a necessary condition for the preparation of highly qualified lawyers.

Lectures are given on the basis of the current criminal legislation of foreign countries and special literature, including in its content a comparative legal analysis of the current legislation of the Russian Federation with the legislation of countries near and far abroad.

As a result of studying the course, students should be able to: apply the criminal law in resolving issues that arise in the practical activities of state bodies; correctly qualify the acts that fall under the signs of a crime; determine the existence of grounds for the release of a person from criminal liability; navigate the criminal law and other normative legal acts; follow the changes and additions made to the Criminal Code of the Russian Federation and comment on them correctly.
