## **1. COURSE GOAL(s)**

The goal of the course “Law Science” is to equip students with basic knowledge about the principles of legal regulation of social relations, the foundations of the state structure, as well as the legislative regulation of activities in the field of healthcare, the rights and obligations of medical workers, etc. Discipline “Law Science” developed for the training of full-time students in the program of training specialists (specialist program) in the direction of 31.05.01 " General medicine ". This course is one of general education and involves familiarizing students with the basics of the theory of law and legislation of the Russian Federation.
