XXI BLISCHENKO CONGRESS "INTERNATIONAL LAW AS A MEANS OF ENSURING PEACE AND TRUST"

Dear Colleagues!

The Department of International Law at the Law Institute of the Peoples' Friendship University of Russia named after Patrice Lumumba (RUDN University) has the honor to invite scholars, practitioners, professors, graduate students and students to participate in the XXI International Congress "Blischenko Readings", which will be held on **April 12**, **2025**, in Moscow in a face-to-face format.

The theme of the Congress is "International Law As a Means of Ensuring Peace and Trust".

The work of the Congress will take place within the framework of the plenary session and in the following round tables:

The Congress will be held at RUDN University at the address: 6 Miklukho-Maklaya str., Moscow. Registration will take place in the lobby of RUDN University's main building from 9.00 to 10.00. The plenary session will be held in the conference hall of the Faculty of Economics from 10.00 to 11.30. Coffee break - from 11:30 to 13:00. Round tables will be held from 13.00 to 17.00. At 17.30 the closing ceremony and summarizing the results of the Congress will begin.

Please note that since this year 1) selection of participants with presentations, and 2) registration to the Congress for both listeners and participants with reports have been separately organized, the dates of which are different.

Those wishing to participate in the Congress **as a speaker** should **submit an application** indicating **the roundtable**, **the intended topic of the presentation and an abstract of 150–300 words by 23:59 (Moscow time) on February 28, 2025** (inclusive, deadline extended). By February 28, 2025, all participants who have submitted their presentations will receive a motivated decision of the Organizing Committee on the acceptance/non-acceptance of the application to participate in the Congress with a presentation based on the results of evaluation of the abstracts of the submitted papers. Applications that do not contain an abstract of the proposed presentation will not be considered.

If you have applied for the Congress with a report (link 1), you have to register one more time via link 2 (you can do it after feedback from the Organizing Committee on the acceptance/non-acceptance of the application with a report).

ALL participants of the Congress, depending on their status and the time of payment, will have to pay an organization fee in the following amount:

The payment link is available on the Congress website since February 1, 2025, as well as is sent automatically to the e-mail specified during registration (link 2). The financial contributions will be used for the publication of the Congress Proceedings and coffee break.

The Congress program will be sent to **all speakers by March 8, 2025**, by e-mail, and will also be published both on the official website of the Department of International Law at RUDN University and the official website of RUDN University.

Following the results of the Congress, the Proceedings will be published, indexed in RSCI. Only papers by full-time participants with 75% originality of the text, without considering the citations according to the results of the anti-plagiarism check, will be accepted for publication.

Articles for publication will be accepted until **23.59 (MSC) on May 12, 2025**. The results of the XXI Blischenko Readings will be published and posted on the website of the Department of International Law (RUDN University) before the XXII Congress.
