General characteristics of the basic educational program in the direction 38.06.01 "Economics" (the level of training of highly qualified personnel), profile "Finance, monetary circulation and credit»

1.1. The purpose (mission).

The purpose of the basic educational program of higher education implemented in the Russian University of friendship of peoples for training in the direction of 38.06.01 «Economics» - the development of students 'social and personal qualities, as well as the formation of universal, General professional and professional competence in accordance with the requirements of the educational standard of higher education the direction of training 38.06.01 «Economics», taking into account the traditions, achievements and characteristics of educational activities RUDN, which contributes to the social mobility of graduate students and meets the needs of the regional labor market.

Post-graduate study objectives:

- 1. The formation of scientific knowledge among graduate students and the acquisition of generic and professional competencies
- 2. Formation of professional competencies in research activities in the field of Economics and teaching among graduate students
- 3. The use of innovative educational and information technologies in the field of education.
- 4. The use of modern scientific-methodical and material-technical support of educational process, consistent with Federal standards for the training of graduate students.
- 5. Attraction for implementation of the basic educational program of the highly qualified teaching staff including having practical experience of work on a profile of the taught disciplines (modules) which are engaged in research and practical activity.
- 6. Organization and conduct of research and teaching practices in the direction focused on the practical consolidation of professional competencies of graduate students and the formation of professional competencies in the direction of training.

Tasks in the field of education of the person:

- 1. Creating the conditions necessary for the comprehensive development of the individual in the socio-cultural environment of the University.
- 2. Development of social and educational component of the educational process: participation of students in public organizations, sports and creative clubs, scientific student societies.
- 3. Formation of moral, spiritual and cultural values and needs, ethical norms and generally accepted rules of behavior in society among graduate students.
- 4. Development of Patriotic, aesthetic feelings and love to work, to his profession, waging healthy way of life.
- 5. Satisfaction of the individual's needs in intellectual, cultural, moral and physical development.
 - 6. The formation of the civilized society norms of behavior.

1.3. Features of implementation of the educational program.

Features of implementation consist in application of e - learning; distance learning technologies; modular principle of presentation of the content of the basic educational program and the construction of curricula; implementation of the program in a foreign language, etc.

1.4. The need of the labor market for graduates of the educational program.

Potential employers – consumers of graduates of the educational program are Universities, banks, insurance companies, various financial analysis company, the educational program focuses on banking, capital markets and the securities market in force, mainly of a practical nature.

The potential entrant of the educational program should have high knowledge in the field of Finance and management, the planned entrance tests include creative competition, the possibility of taking into account the portfolio.

Market leading companies link their further development and strengthening of competitiveness with increased control in conditions of economic instability. Thus, the requirements for qualification and competence of specialists-financiers are constantly increasing. The economic crisis has shown how important is the ability of companies to control their costs and find ways of rational solutions in the field of planning business processes to maintain business stability in difficult economic conditions. High requirements in business today, the qualification of staff in Finance, require a multi-stage structure of training of young specialists, competitive on the labor market.

Potential employers-consumers of graduates of this educational program are enterprises and organizations of almost all sectors.

1.5. Requirements for the applicant.

The applicant must have a document of higher education (specialist or master).

The applicant must have creative thinking; have formed motives and cognitive interests, the need for continuing education and self-education:

- in the communicative field: be able to establish contacts with others, respect other tastes, customs, habits; have a high social adaptability;
- in the spiritual and moral field: to have a conscious civic position, a sense of pride in belonging to their nation, humanistic attitude to other peoples, the ability to reflect; to realize the priority of spiritual and moral values over material values.;
- in the professional field: to be ready for meaningful and conscious professional self-determination, to work and self-realization in society; to have the ability to constructive, scientific organization of work; to show criticism, optimism, mobility.

The University carries out the reception of citizens of the Russian Federation, foreign citizens and persons without citizenship (further - citizens, persons entering, entrants) for training on educational programs of higher education on the basis of the Rules of admission to Federal state Autonomous educational institution of higher professional education "Russian University of friendship of peoples" for training on educational programs of higher education – training programs of personnel of higher qualification.

Admission to study on postgraduate programs is carried out on the basis of the results of the written interdisciplinary exam in the direction 38.06.01 "Economics", which are recognized as the results of entrance examinations, evaluated on a 100-point scale.

1.6. Characteristics of professional activity of graduates of the educational program:

1.6.1. Field of professional activity.

The field of professional activity of graduates who have mastered the postgraduate program includes economic theory, macroeconomic management, regulation and planning, Economics and enterprise management, industries and interindustrial complexes, management, marketing, logistics, innovation management, finance, money circulation and credit, accounting, statistics, mathematical and instrumental methods of economics, world economy, business economics.

1.6.2. The object of professional activity.

The objects of professional activity of graduates who have mastered the postgraduate program are:

- conceptual (fundamental) problems of economic science, including methods of economic analysis;
 - applied problems of functioning of various economic agents, markets and systems.

1.6.3. Types of professional activity.

Financier, financial Manager, risk Manager, insurer, qualified investor, etc.

Postgraduate training direction 38.06.01 "Economics", profile "Finance, monetary circulation, credit" is preparing for the next kinds of professional activities:

- analysis of current trends and forecasts of economic development, determination of scientific justified organizational and economic forms of activity;

 - the teaching of Economics and teaching work in the fields professional activity;

- identification, analysis and resolution of problems of national innovation development economy, management of the main parameters of innovative processes in modern economic, scientific, technical and organizational renewal of social and economic systems, methods and tools for the evaluation of the results of innovative activities;
- planning, organization and management of material and information flows, financial and human resources with a view to their rationalization;
- fundamental and applied research of industry, regional and world markets; organizational and economic activity of market subjects;
- development of theoretical and methodological principles, methods and methods management of social and economic systems;
- analysis of current trends and forecasts of economic development, determination of scientific justified organizational and economic forms of activity;

- readiness to participate in the work of Russian and international research teams to solve scientific and educational problems (UC-3);
- readiness to use modern methods and technologies of scientific communication in the state and foreign languages (UC-4);
 - the ability to follow ethical standards in their professional activities (UC-5);
- ability to plan and solve problems of own professional and professional personal development (UC-6).

A graduate who has mastered the postgraduate program should have the following: General professional competences:

- ability to independently carry out research activities in relevant professional field with the use of modern methods research and information and communication technologies (GPC-1);
- readiness to organize the work of the research team in the scientific industry, relevant field of study (GPC -2);
 - readiness for teaching activities on educational programs higher education (GPC -3).
