Description of the educational program "Political Science: Russian and Comparative Studies".

General characteristics of the program.

1.1. The purpose (mission) of the program

The study of political systems, political processes and the political consciousness of regions and countries, their specifics and the methodology of their diverse research and comparative analysis. Disclosure of the nature and essence of the Russian state companies on the basis of a broad spectrum of research approaches. Developing skills of analytical and prognostic activities of the students, abilities to apply them in practical research activities and educational process.

1.2. Basic information.

Educational program higher education program training of scientific and pedagogical personnel of higher qualification in postgraduate study.

Graduate qualification: researcher, lecturer / researcher.

Form of training - full-time

The term education in the graduate program in full-time education, including vacation granted after passing the state final examination, is 3 years.

The scope of the program of postgraduate studies is 180 credits and includes all types of academic studies, independent and research work of the student, the internship as well as the time taken for the quality control of the development of a postgraduate educational program.

Place of implementation of the program is the faculty of Humanities and social Sciences of the RUDN University (Russia, Moscow).

1.3. Features of implementation of the program.

The program is in English, classes are in English.

The use of modular principle where the content of the basic educational program and building a curriculum. Significant emphasis on scientific research. The involvement of students in the educational and research processes.

1.4. The needs of the labour market for graduates of the program.

Graduates of the program could work in state and municipal administration in foreign countries, political organizations, commercial and non-commercial structures, consulting and analytical centers, mass media, academic and research organizations.

1.5. Requirements to the applicant.

Applicant must possess professional training in the social Sciences and have completed higher education. Applicant must orient in the modern political theories, the issues of interrelation of the General and particular at the level of regional policies, strategies finding an answer to the changed parameters of modernity and in-country transformation. Skills of analysis of political processes and the political consciousness of regions and countries, their specifics and methodology of the research and comparative analysis. Study skills-specific and entity of the Russian society through a range of research approaches.

1.6. Characteristics of professional activity of graduates of the program:

1.6.1 The Area of professional activity of graduates who have completed the graduate program includes:

- decision of professional tasks in various fields of political science and higher education;
- various spheres of socio-political, socio-cultural and economic space of the countries of the world;
- the structure of state government and administration (Federal, regional and municipal levels);

- political parties and political movements;
- regional and international organizations, the system of modern international relations;
- political culture, the interaction of government, business and civil society;
- educational organization of higher education.

1.6.2 The Objects of professional activity of the graduates who have completed the graduate program are:

- political, economic, social and demographic processes at the local, regional, national and international levels;
- international relations and foreign policy;
- political expertise and political advice;
- problems of political development;
- processes in the sphere of mass communications, as well as culture, ethnicity, language and religion.

1.6.3 The Types of professional activities.

Types of professional activity of graduates:

1.1. training of highly qualified scientific and scientific-pedagogical personnel, formation and development of their competencies according to professional standard;

1.2. the final original research, contributing to the creation, expansion and development of scientific knowledge.

A) research activities in the field of political science, foreign regional studies and regional studies of Russia, international relations, Oriental studies and African studies, public policy and social Sciences:

- fundamental research in the field of political science and regional studies;
 - research in the field of theory, history and philosophy, political processes, methodology of political science;
- research national, regional and global political processes;
- development and improvement of theoretical and instrumental methods of political analysis and forecasting;
 - implementation of applied research based on fundamental methods of political analysis;
 - analysis of current trends and forecasts political development;
 - improvement of management and governance and regulation.

B) teaching in political science, foreign regional studies and regional studies of Russia, international relations, Oriental studies and African studies, public policy and social Sciences:

- development of courses on areas of professional activities, including on the basis of the results of the conducted theoretical and empirical studies
- the teaching of Economics and teaching work in the fields of professional activities;
- conducting research work in the educational organization, including the management of research work of students.

1.6.4 Objectives of professional activities.

Clarification of the specificity and nature of Russian society in the mainstream of a civilized approach, the formation of an adequate understanding of Russian civilization as a sustainable education and its importance in world history and modern features. This goal is interpreted as a methodological recognition of Russia's status as a civilized education with its inherent objective characteristics that determine its place in world history.
