1. THE MISSION (SOCIAL SIGNIFICANCE) OF THE PROGRAM

The mission (social significance) of the program 5.6 "Historical Sciences", specialty 5.6.7. - "History of international relations and foreign policy" is training of highly qualified personnel (postgraduate study) - training of researchers, teachers and researchers who are able to carry out scientific research activities in the field of history, international relations and foreign policy, as well as teaching activities in educational programs of higher education, taking into account modem requirements.

Task of the program is training of highly qualified specialists, development of students' personal qualities that meet the requirements for work in higher education institutions, research organizations and other structures that carry out scientific research and training of citizens.

The content of specialization is the study of history of international relations and foreign policy, as well as the patterns and features of development of the modern system of international relations, the main priorities of foreign policy of various countries, including Russia. Within the framework of the specialty, the activities of various international intergovernmental and non-governmental organizations, associations, socio-political movements, military blocks are investigated. The whole set of historical sources is studied, including archival materials, contracts, agreements and other diplomatic documents, media materials, memoirs, and statistical data.

An important role in practical application of theoretical knowledge and formation of skills is played by pedagogical internship, scientific research and language and specialized internships. Postgraduate students are actively involved in research work, participate in international scientific and practical conferences, publish their work in various collections and journals, including the Vestnik RUDN and publications indexed in Scopus and the Web of Science.

In the course of mastering the program, graduate students carry out an original scientific research and, by the end of their studies, prepare the text of the thesis for presentation.

2. RELEVANCE, SPECIFICITY, UNIQUENESS OF THE EDUCATIONAL PROGRAM

The program is being implemented in accordance with the independently established requirements of RUDN University (Order No. 139 dated March 9, 2022).

As part of the educational process, graduate students will have the opportunity to work with highly qualified teachers; take part in research projects of the Department of Theory and History of International Relations, study modern educational and methodological complexes and listen to the courses on international relations and foreign policy, study the methodology of scientific research, get acquainted with the features of historiography and source studies, as well as topical problems of historical science.

The innovative model of teaching during the program 5.6.7 "History of International Relations and Foreign Policy" is characterized by:

- fundamentality;
- practical orientation;
- modern educational technologies.

During choosing a dissertation topic, graduate students of the program 5.6.7 "History of International Relations and Foreign Policy" are guided mainly by perspective areas of research:

- globalization and regionalization general and special, contradictions of two processes;
 - transformation of the world order and the problem of global governance;
 - political leadership of regional powers and dialogue of civilizations;
- strategic direction and dynamics of interaction between global international actors (USA China EU Russia Greater Middle East);
 - formation of a stable system of international security.

3. THE NEEDS OF THE LABOUR MARKET FOR GRADUATES OF THE PROGRAM

Graduates of the program for training highly qualified scientific and pedagogical personnel carry out labor activity in the central apparatus of the Russian Foreign Ministry, foreign embassies and consulates, in diplomatic institutions of foreign countries, in international organizations, commercial firms, research centers, universities in Russia and abroad.

Graduate students who have mastered the program "Historical Sciences and Archeology" in the specialty "History of international relations and foreign policy" can be in demand by management structures of various levels, party-political and public organizations. The media may be interested in them, as well as institutions in charge of intercultural interaction, the development of international relations and tourism.

Potential employers: organizations associated with international activities (Foreign Ministry, embassies, consulates, centers and funds for cultural cooperation with foreign countries, international organizations), local and state authorities; regional and republican self-government; public organizations; mass media (TV, newspapers, journals, Internet portals);); archives, museums, libraries; tourist and excursion organizations; expert analysis centers; educational institutions of higher education; academic institutions (institutes of the Russian Academy of Sciences).

5. REQUIREMENTS TO THE APPLICANT

Applicant must possess professional training in the social Sciences and have completed higher education (knowledge obtained in the Master of Arts -history, political science, history of international relations, sociology, etc.). Applicants must be prepared for the fact that in the process of learning they will be required to work hard, show their analytical and creative skills, knowledge of a foreign language, skills of reviewing and writing scientific texts, as well as translations of scientific literature.

6. FEATURES OF THE IMPLEMENTATION OF THE PROGRAM

- 6.1. The program is implemented with elements of e-learning/distance learning technologies. Within the framework of educational disciplines, the TUIS RUDN system is used, as well as programs for video conferencing, if it is necessary.

- 6.3. The program is adapted for teaching the disabled and people with disabilities.
