Подготовка текста диссертационного исследования осуществляется аспирантом на протяжении всего срока обучения и завершается представлением, как правило, на третьем году обучения, законченного текста научно-квалификационной работы (диссертации) научному руководителю и, при наличии положительного отзыва научного руководителя, экспертной комиссии профильного подразделения (кафедры). Результаты научно-исследовательской работы аспирант обобщает в научных публикациях. Апробация результатов самостоятельного научного исследования аспирантом осуществляется также в ходе его участия в профильных научных

мероприятиях (конференциях, семинарах, круглых столах и др.). Государственная итоговая аттестация включает: подготовку к сдаче и сдачу государственного экзамена по направлению и профилю подготовки, как правило, в конце третьего года обучения; представление научного доклада об основных результатах подготовленной научно-квалификационной работы (диссертации), оформленной в соответствии с требованиями, устанавливаемыми Министерством образования и науки Российской Федерации.

Information about features of the implementation of the basic studying program:

Implemented in English.

1. The purpose (mission) of the program

The study of political systems, political processes and the political consciousness of regions and countries, their specifics and the methodology of their diverse research and comparative analysis. Disclosure of the nature and essence of the Russian politics on the basis of a broad spectrum of research approaches. Developing skills of analytical and prognostic activities of the students, abilities to apply them in practical research activities and educational process.

Form of training - full-time

The term of education in the post-graduate program in full-time education, including vacation granted after passing the state final examination, is 3 years.

The scope of the program of post-graduate studies is 180 credits and includes all types of academic studies, independent and research work of the student, the internship as well as the time taken for the quality control of the development of a postgraduate educational program. Place of implementation of the program is the faculty of Humanities and social Sciences of the RUDN University (Russia, Moscow).

Features of implementation of the program. The program is in English, classes are in English.

2. RELEVANCE, SPECIFICITY, UNIQUENESS OF THE EDUCATIONAL PROGRAM

The unique mission of the RUDN and its successful practical implementation in the educational process provides the opportunity to teach taking into account the processes taking place in world politics in various cultural, civilizational, economic and religious conditions. The program gives the opportunity to study political systems, political processes and political consciousness of Russian society, as well as the methodology of their comprehensive research and comparative analysis. Disclosure of the specifics and essence of the Russian state and society on the basis of a wide range of research approaches. The main attention is paid to the historical evolution of political systems, political processes and political consciousness of Russian society in the period after the end of the Cold war and the formation of a new system of international relations

3. The needs of the labour market for graduates of the program.

Graduates of the program can work in state and municipal administration in different countries, political organizations, commercial and non-commercial structures, consulting and analytical centers, mass media, academic and research organizations.

5. Requirements to the applicant

The applicant must have professional training in the field of social sciences, have completed higher education. He should be guided by modern political science theories, in the issues of the correlation of the general and the special at the level of domestic and world politics of regional politics. The applicant must have the skills to analyze political processes and political consciousness of regions and countries of the world. It is desirable to have the skills to study the specifics and essence of Russian society based on a wide range of research approaches.

A potential applicant should be ready for activities that require in-depth research and pedagogical training and have the following competencies:

- general cultural competencies: ability to abstract thinking, analysis, synthesis; willingness to act in non-standard situations, to bear social and ethical responsibility for decisions made; willingness to self-development, self-realization, use of creative potential;
- general professional competencies: readiness to communication in oral and written forms in Russian and foreign languages to solve the tasks of professional activity; willingness to lead a team in the field of their professional activities, tolerantly perceiving social, ethnic, confessional and cultural differences; ability to make organizational and managerial decisions;
- professional competencies in the field of research activities: the ability to generalize and critically evaluate the results obtained by domestic and foreign researchers, identify promising areas, draw up a research program; the ability to substantiate the relevance, theoretical and practical significance of the chosen topic of scientific research; the ability to conduct independent research in accordance with the developed program; the ability to present the results of the research to the scientific community in the form of an article or report.

6. FEATURES OF THE IMPLEMENTATION OF THE PROGRAM

6.1. The Program is implemented with elements of e-learning/distance learning technologies (lectures, seminars, testing).

6.2. The language of realization of the Program is English.

6.3. The program is adapted for teaching disabled people and persons with disabilities.

6.4. The EP is implemented by the Federal State Educational Institution of the Peoples' Friendship University of Russia.

- analysis of current trends and forecasts of political development;
- improvement of management and governance and regulation.

B) teaching in political science, foreign regional studies and regional studies of Russia, international relations, Oriental studies and African studies, public policy and social Sciences:

- development of courses on areas of professional activities, including on the basis of the results of the conducted theoretical and empirical studies

C) conducting research work in the educational organization, including the management of research work of students.
