11. Methodical Instructions for Students on the Development of Discipline (Module)

For the successful development of the discipline you need to repeat sections:

- legal framework for health from the course of law,
- the basics of information security from the course of bioethics,
- working conditions as factors that affect population health, from the course of General hygiene,
- principles of epidemiological safety from the Department of epidemiology,
- principles of work of ambulatory-polyclinic and stationary medical institutions from the course of the organization of health,
- the principle of health-protective regime as a sine qua non of sanogenesis of the courses of normal and pathological physiology, paediatrics, surgery, therapy, traumatology, neurology, obstetrics, psychiatry.

When studying issues submitted for independent development, you should use the

recommended literature (available in the University's Telecommunications Educational and Information System), the database of clinical recommendations of the Ministry of Health of the Russian Federation and the database of samples of registration of disability sheets of the Social Insurance Fund of the Russian Federation.

It is recommended to get acquainted with the legal and regulatory framework for the examination of temporary disability using the ConsultantPlus and Garant programs, to which there is round-the-clock access from university computers and evening and Sunday access from home computers. This guarantees familiarity with the latest versions of laws and orders, which is necessary for mastering theoretical material, preparing reports, solving situational problems.

To get acquainted with the practice of issuing disability sheets and certificates of the form N 095/y (Certificate of temporary disability of a student, a student of a technical school, a vocational school, about illness, quarantine and other reasons for the absence of a child attending school, a preschool institution) and maintaining a Book of registration of disability sheets (Form N 036/y), students are given the opportunity to independently study in the office of registration and issuance of disability sheets in the basic medical institution-the RUDN Medical Center.

Educational materials in electronic form on a number of studied topics are posted on the discipline page in the University's Telecommunications Educational and Information System, on the local resources of the electronic library system of the RUDN. If distance learning is necessary, the Microsoft Teams corporate platform based on Office 365 can be used.
