1. GOALS AND OBJECTIVES OF THE COURSE

The aim of mastering the course "**Organization of veterinary affairs**" is the formation of theoretical knowledge on the main issues of the structure of the veterinary service of the Russian Federation, regulatory and legal documentation in the field of veterinary medicine, the organization of state veterinary supervision and practical skills in drawing up plans of veterinary measures to prevent the occurrence of infectious and mass non-infectious animal diseases, calculating the economic efficiency of veterinary measures, maintaining veterinary records. The aim is to ensure proper reporting and rationing of the work of veterinary workers.
