1. COURSE GOAL(s)

The goal of the course «Private International Law Issues in the Field of Transnational Insolvency» is to prepare students [seeking master's degree of law] to the perception and practical application of the basic rules of Transnational (cross-border) insolvency (bankruptcy).

The objectives of the course are:

- to define the scope and practical application of the set of rules, known as Transnational (cross-border) insolvency (bankruptcy) law [hereinafter TIL]
- to define a conceptual apparatus of TIL:
 - a. What are the characteristics of "law" TIL has.
 - b. The meaning of "ttransnational" in the term "Transnational (cross-border) insolvency (bankruptcy) law".
 - c. The meaning of "Insolvency and/or Bankruptcy" in the term "Transnational (crossborder) insolvency (bankruptcy) law".
- to identify the subject of public relations regulated by TIL.
- to establish a method by which TIL relations are regulated and its differences from the methods of regulation of procedural (litigation) law relations and those [relations] of civil legal nature.
- to identify normative structure of TIL: conflict of laws [structure, types], the rules of substantive law, procedural rules, types of references in Transnational Insolvency (Bankruptcy) law.
- to give a concept of Transnational (cross-border) insolvency (bankruptcy) law containing the so-called "foreign element" and definition of the so-called "transborder/transboundary".
- to give a concept and identify types of collisions in Transnational (cross-border) insolvency (bankruptcy) law. Show how conflicts are resolved in practice and the role the definitions: «national (domestic) legislation » and «foreign jurisdiction».
- to determine the possibility of application of the judicial acts of a foreign state which have prejudicial in the insolvency proceedings.
- today's basic principles of TIL in historical retrospect of their origin and development.
- to characterize the sources and subject composition of TIL.
- to prove that TIL is a complete and unique in its kind intersystem body of law.
- to describe the history and development of To prove that TIL is a complete and unique in its kind intersystem body of law: evolution of views on the necessity and inevitability of applying foreign law to regulate To prove that TIL is a complete and unique in its kind intersystem body of law relationships.
- to identify the current status and perspective of development of Transnational (cross-border) insolvency (bankruptcy) law in the light of globalization
