- to teach students to use independently any latest research methods to evaluate events and processes occurring in the modern world

- to develop basic skills of research work and analytical evaluation of information on the main directions of professional activity

- to help students master the skills of academic writing and discussion.

5. The content of the discipline

5.1. The content of the course

Section 1. Research Methods in International Relations and Foreign Policy in the Digital Era

Topic 1. Digital research methods and traditional structures of MO. Challenges of the information society. The role of scientific research in modern international relations, the types of scientific research, the role of socially generated information and traditional channels of influence, the problem of long-term and repeated use of data, the generalization of results. Infrastructure of academic knowledge and decision making in IR.

Theme 2. Cross-cultural aspects of studies of international relations and foreign policy.

Ethical code of a researcher. Linguistic diversity, the study of language policy and its role in international relations, a critical analysis of the theory of "global" knowledge, problems of the blogosphere and wiki.

Theme 3. International and political organizations in the digital age: the problematization of Internet presence. Analysis of network presence of organizations, network organizational analysis, methods of analyzing websites, the use of traffic analysis in political forecasting.

Topic 4. Online research: Internet as data and tool for research. Network analysis. Studies of civic participation and its negative manifestations in the form of hakkig, trolling. Methods of studying digital terrorism, disinformation and digital terrorism.

Topic 5. Methods of studying military and social conflicts (migration, environmental disasters), analysis of existing international agreements applied to the challenges of today. The problem of effective response and prediction in IR. Analitical approaches to the refugees' question.

Theme 6. Acquaintance with research paradigms from social and human sciences.

Application of the theory of social reproduction (P. Bourdieu), semiotics (M. Lotman), situational analysis (M. Foucault) in the IR studies.

Section 2. Academic writing skills, presentations and preparation for writing of a scientific article.

Topic 7. Analysis of typical errors in writing first academic articles.

The choice of topics, work with and selection of sources of information, analysis of the argument.

Topic 8. Preparation a review writing

The structure of the text, work on the paragraph, academic style and citations in publications. Analysis of reviews in the field of international relations and foreign policy. Features of the publication and

requirements. Critical text analysis, constructive criticism and professional ethics.
