1. EDUCATIONAL PROGRAMME GOAL (MISSION)

The educational program aims **to** develop students' personal qualities, the formation of universal, general professional competencies in accordance with the requirements of the Educational Standard of Higher Education of RUDN University in the direction of training 40.04.01 "Jurisprudence" qualification "Master", as well as professional competencies within the profile - "International Private Law".

Within the framework of the orientation (profile), an in-depth study of the main institutions of private international law, the study of the general theory and fundamental principles of private international law, the qualification of relations in this area, the study of the features of the regulation of cross-border relations of a private law nature, as well as the study of foreign and cross-border experience are carried out; formation of skills of expert consulting activities and conducting legal research in the field of private international law; formation of skills in teaching legal disciplines and legal education.

The mission of the EP is to train highly qualified, competitive specialists with the necessary competencies and qualities, with a high level of legal culture and legal awareness, demanded by the modern labor market, the state and society.

2. EDUCATIONAL PROGRAMME RELEVANCE, SPECIFICITY, AND UNIQUENESS

Graduates gain knowledge and skills in law enforcement, consulting, research, and teaching activities in the field of law.

The types of professional activity of the graduate are the implementation of legal norms in the field of private international law, the application of regulatory legal acts in this field of legal activity, the implementation of the norms of private international law, the performance of official duties to ensure the provision of qualified legal support, giving advice on legal issues both orally and in writing; preparation of documents of a legal nature; organization and conduct of legal research, teaching of legal disciplines, including the management of the student's independent work.

The emphasis in training is on mastering the skills of analytical work with legal material; methods of legal technique in law enforcement; The program is unique in its interdisciplinary focus and research potential.

The venue of the program is the Law Institute of the Peoples' Friendship University of Russia (Moscow, Russia).

3. LABOUR MARKET NEEDS FOR PERSONNEL TRAINING IN EDUCATIONAL PROGRAMME PROFILE

The demand for graduates of the educational program in the labor market is one of the most important indicators of the effectiveness of training, which is ensured through close interaction with potential consumers of graduates at the regional and federal levels. Permanent partners are courts of general jurisdiction and arbitration courts, as well as foreign consulting companies. Upon completion of training, graduates will be able to successfully work in positions of the state (municipal) service, in the legal departments of commercial organizations; in international and Russian legal consulting companies. The fundamental knowledge and research skills acquired within the framework of this master's program allow graduates to further carry out scientific research in the field of law, to teach legal disciplines.

4. SPECIAL REQUIREMENTS FOR POTENTIAL APPLICANTS

Persons with higher education, confirmed by a state-recognized document on higher education (qualification bachelor or specialist), are allowed to master the master's program.

Admission to master's programs is carried out on a competitive basis based on the results of the entrance exam (portfolio).

Admission to the educational program is carried out on the basis of a competitive selection, for which the applicant, in accordance with the annually approved Rules for admission to the Peoples' Friendship University of Russia for applicants for training in educational programs of higher education - master's programs, submits: a) a package of documents forming the applicant's personal file and b) a portfolio, which is evaluated by the examination commission during the entrance test.

5. FEATURES OF THE IMPLEMENTATION OF EP VO

- 5.1. EP HE is implemented without the *use* of e-learning / distance learning technologies.
- 5.2. The language of implementation of the EP HE is *English*.
- 5.3. The program can be adapted for people with disabilities and persons with disabilities.
