1. COURSE GOAL(s)

The discipline "Emergency conditions in outpatient dental practice" is included in the program of the specialty "Dentistry" in the direction 31.05.03 "Dentistry " and is studied in the 7 semesters of the 4th course. The discipline is implemented by the Department of General Medical Practice. The discipline consists of 3 sections and 10 topics and is aimed at studying the peculiarities of the work of a medical doctor in primary health care.

The goal of the course is to provide training for doctors in the specialty "Dentistry", focused on working in primary health care.

2. REQUIREMENTS FOR LEARNING OUTCOMES

Mastering the course (module) "Emergency conditions in outpatient dental practice" is aimed at the development of the following competences /competences in part: GC-5, GPC-6, GPC-7.
