The goal of the Technological internship for second-year full-time students in the International Economic Relations program is to get acquainted with the activities of various organizations and gain practical experience in performing specific functional tasks within the framework of the curriculum.

# **Forms of Technological Training**

Work as an assistant to specialists in planning, economics, management, logistics, and other departments related to the economic activities of the enterprise.

Self-study of normative literature.

The goal of the technological training is to apply the knowledge gained from the study of core and variable

**Preliminary stage**. The content of the introductory lecture: setting goals, objectives, determining the time and place of internship; acquaintance with the leaders of the practice; instruction on keeping a diary of practice, design and defense of the practice report; organizational issues of internship; briefing on safety techniques and fire safety.

The result of the preliminary stage should be a completed individual application for practice. Individual tasks are mandatory for execution of students.

The calculation and analytical stage consists in studying the activities of the enterprise and involves the participation of the trainee in performing a number of works at the enterprise in accordance with the instructions of the head, collecting various information, conducting various calculations and completing an individual task.

The final stage is to prepare and defend the internship report to the supervisor.

#### 7. INTERNSHIP LOCATION AND TIMELINE

For pre-diploma practice, the following types of enterprises and departments are recommended for bachelor's students:

- 1. planning and economic subdivisions of enterprises and organizations of any organizational and legal forms and directions of various sectoral nature;
- 2. sales, logistics, statistics and any other divisions of the company;
- 3. departments or other structural units of the university, where research work related to the study of industries and industry markets is carried out.

Bases of practice for bachelors must meet the following basic requirements:

- 4. correspond to the direction of preparation of the bachelor of economics;
- 5. have qualified personnel to manage the practice of bachelors;
- 6. provide trainees with regulatory, reporting and other documentation necessary for analyzing the activities of the company (division) and writing a report on practicality.

The duration of practice in the 2nd year is 2 weeks (3 ZE, 108 hours) The specific terms of practice are set by the curriculum.
