## 1. COURSE GOALS

The course "Human Rights and International Security" is part of the Master's program "World Politics: Conceptual Foundations and Intercultural Interaction" in the field of 41.04.05 "International Relations" and is studied in the third semester of the second year. The course is offered by the Department of Theory and History of International Relations.
