1. COURSE GOAL(s)

The discipline "Polyclinic therapy" is included in the program of the specialty "General Medicine" in the direction 31.05.01 "General Medicine " and is studied in the 9th, 10th, 11th, 12th semesters of the 5th, 6th courses. The discipline is implemented by the Department of General Medical Practice. The discipline consists of 2 sections and 21 topics and is aimed at studying the peculiarities of the work of a medical doctor in primary health care.

The goal of the course "Polyclinic Therapy" is to provide training for doctors in the specialty "General Medicine", focused on working in primary health care.
