1. COURSE GOAL(S)

The discipline "Examination of temporary disability" is included in the program of the specialty "General Medicine" in the direction 31.05.01 "General Medicine" and is studied in the 12th semester of the 6th year. The discipline is implemented by the Department of General Medical Practice. The discipline consists of 6 sections and 12 topics and is aimed at studying the theoretical and practical issues of the examination of temporary disability.

The goal of the course «Examination of Temporary Disability» is to form students' knowledge, skills and abilities of conducting an examination of temporary disability, interacting with the medical commission of a medical institution and timely referral of a patient for a medical and social examination.

2. REQUIREMENTS FOR THE RESULTS OF MASTERING THE DISCIPLINE

The development of the discipline "Examination of temporary disability" is aimed at the formation of the following competencies (parts of competencies) among students:
