## **1. EDUCATIONAL PROGRAMME GOAL (MISSION)**

The purpose of the Programme is to provide high-quality training of competitive and competent professionals with systemic knowledge in the field of translation and interpreting theory, practical skills in interpreting and translation in the humanitarian field in general, and in the fields that are subject to state and public institutions services provision, in particular; the course aims to train specialists who are also able to carry out consultative and communicative, expert-analytical, and pedagogical activities, that are in demand in the modern labor market and in the contemporary society.

The mission of the Programme is to meet the educational needs that the contemporary society articulates regarding the implementation of translation and interpreting in socially significant contexts, as well as to form a comprehensive transfer of educational information in the main areas of development of the translation studies, the practice of translation and interpreting for public services and institutions, the use of ICT in translation and interpreting.

## **2. EDUCATIONAL PROGRAMME RELEVANCE, SPECIFICITY, AND UNIQUENESS**

The specificity of the Educational Programme, which distinguishes it favourably from other similar programmes implemented at the leading universities of Russia comprises a number of issues.

First, the Programme provides theoretical and practical training that reveals the importance of translation and interpreting for ensuring human rights and needs in the field of healthcare, education, in the interaction with the state bodies and commercial entities. Further, the Programme forms a set of analytical and practical skills in the field of translation and interpreting for the legislative, judicial and executive (law enforcement) authorities, as well as for the legal support of the corporate entities activities, for the interaction in the field of healthcare and education.

## **3. LABOUR MARKET NEEDS FOR PERSONNEL TRAINING IN EDUCATIONAL PROGRAMME PROFILE**

Upon the completion of the Programme, the graduates' competences, knowledge and skills are relevant and in demand in the industry market for those who strive to apply for a job as an interpreter and translator in international organizations, foreign and Russian companies, a conference interpreter, as well as a translator and interpreter, translation editor or head of translation projects for public authorities involved in healthcare, education, law and order issues, as well as for corporations and commercial structures.

Regular contacts have been established with potential employers at the international, regional and federal levels.

## **5. SPECIAL REQUIREMENTS FOR POTENTIAL APPLICANTS**

- Individuals with a higher education diploma;
- Level B2 (CEFR) as the minimum level of the English language proficiency required for admission to the Programme.

To enrol in the Programme, the applicant provides a portfolio that takes into account the data of a diploma of higher education, the quality of a resume, a motivation letter, the

certificates and diplomas that confirm a foreign language proficiency, the presence of publications in a foreign language in scientific journals, and other achievements.

The enrollment procedure also includes a creative written task: translation of the English-language newspaper article on humanitarian topics, 1000 characters and an oral interview in which the applicant comments on the strategy and tactics, the transformations used in the course of the translation.
