The development of the discipline is carried out within the framework of the implementation of the main professional educational program of higher education:

1. THE PURPOSE OF MASTERING THE DISCIPLINE

The discipline "Customs and Tariff Regulation and Non-Tariff Regulation" is included in the master's program "International Trade" in the direction of 38.04.01

"Economics" and is studied in the 2nd semester of the 1st year. The discipline is implemented by the Department of International Economic Relations. The discipline consists of 2 sections and 11 topics and is aimed at studying customs and tariff regulation and non-tariff regulation

The purpose of the discipline is to form a systematic perception of customs and tariff regulation and tools for its implementation in the Eurasian Economic Union, as well as to master practical skills in using the regulatory framework of customs and tariff regulation in foreign trade.

2. REQUIREMENTS FOR THE RESULTS OF MASTERING THE DISCIPLINE

The development of the discipline "Customs and Tariff Regulation and Non-Tariff Regulation" is aimed at the formation of the following competencies (parts of competencies) in students:
