## 1. COURSE GOAL

The objective of the course is to improve professionally oriented foreign language competence of postgraduate students to optimise scientific and professional activities by using a foreign language in scientific design and research work.

The implementation of this goal is realized by solving the following tasks:

- formation and improvement of foreign language communicative competence in various types of professionally oriented speech activities, based on the starting level of foreign language knowledge,
- formation of skills in foreign language design and research activities in the sphere of education,
- formation of foreign language skills in educational sphere,
- formation and improvement of professionally oriented translation competence (ability) to translate orally and in writing from a foreign language into Russian and from Russian into a foreign language fragments of special / academic texts and documents in accordance with the norms of the mother tongue and foreign language under study in volume, defined by course syllabus),
- mastering the norms of foreign language etiquette in the professional and scientific fields of cooperation.

## 2. REQUIREMENTS FOR LEARNING OUTCOMES

The course suggests certain foreign language communicative competence and provides for different initial levels of students' language proficiency. Possible starting levels to learn a foreign language in postgraduate education are levels B1, B2 and C1.

According to the results of mastering the course regarding the system of the foreign language, PhD students are expected to

- ☐ know the features of foreign language functioning in the field of scientific and professional communication, pragmatic and stylistic characteristics of linguistic units and their use in scientific and institutional educational discourse,
- ☐ master the lexical minimum of up to 5500 units, taking into account the university minimum and potential vocabulary, including approximately 500 terms of a majoring specialty,
- ☐ master grammar (morphological categories, syntactic units and structures) to the extent determined by the syllabus with regard to the specifics of lexical and grammatical arrangement of relative documents and academic texts on scientific, professional, sociocultural and educational issues,
- ☐ be able to identify linguistic differences in the genre-stylistic varieties of academic texts on relative issues; make statements according to the rules of corresponding genre in accordance with specific communicative-pragmatic aims in a codified communication situation.

According to the results of mastering the course regarding the system of the foreign language, PhD students are expected to be able to carry out interrelated types of the communication in a foreign language in the legal sphere, including:

*in speaking:* deliver a prepared as well as an unprepared monologue, make resumes, messages, and a report in a foreign language; support a dialogical speech in situations of

scientific, professional and everyday communication within the studied language material and in accordance with the chosen specialty.

*in listening:* understand by ear the authentic monologue and dialogue within the specialty, based on the studied linguistic material, national background and professional knowledge, language and contextual guessing skills; understand the specifics of compositional structure of the academic / specialised text; be able to evaluate the content of the audio text from the point of view of the degree of system connections between facts and phenomena, reasoning and importance of information within professional and corporate interests.

*in reading:* read, understand and use in their scientific research original academic literature within their specialty, relying on the studied language material, background national and professional knowledge and language and contextual guessing skills; master all types of reading (studying, fact-finding, skimming and scanning).

*in writing:* demonstrate writing skills within the studied language material, in particular, be able to draw up a plan (compendium) of what was read, write the contents of what was read in the form of a resume/brief summary, prepare a written message or report on the issues of scientific research with a clear compositional structure in accordance with lexical, grammatical and stylistic norms of the studied language.

*in translation:*

- be able to draw up information extracted from foreign sources in the form of a full and abstract translation and/or summary in accordance with the norms and typology of texts in the target language,
- be able to translate a scientific / specialized text from a foreign language into Russian within the requirements defined by the curriculum,
- be able to use dictionaries, reference books, and other sources of additional information.
